

Restrictions for Lonesome Pine Subdivision:

The following covenants will run with the land for a period of 10 years from transfer title for all Lots in Lonesome Pines Subdivision:

- 1. Lots less than 5.0 acres are limited to one residence per lot. Lots of more than 10 acres may add one additional home upon approval of the Burke County authorities.
- 2. All residences may be either home or mobile home. Any mobile home placed thereon shall be double wides and shall be not more than 10 years old since date of manufacture. Any residence constructed or placed thereon shall have a minimum of 980 square feet or heated floor space of living area.
